On the value of public sector benefits... "CSEA negotiates the EBF's benefits on behalf of the members whenever possible because we understand the value they bring to the table. When access to dental and vision benefits are solidified in contracts, surprise costs are minimized especially at a participating provider. These savings are something I experienced first hand with my medically required visits to the optometrist and my son's substantial dental work a few years back. Like me, CSEA members and their families can have peace of mind that benefits from EBF can help save money and keep their families healthy."

On knowing your CSEA benefits... "Knowledge is power! Every member should be aware of the benefits and services CSEA can provide them, including negotiated benefits like the EBF dental and vision plans. Dental and vision benefits that include regular exams can help detect underlying health issues which can be addressed and treated before they become serious. Take advantage of region, local and unit information days and membership meetings and talk to the representatives to learn about what your benefits are and how to use them. The EBF's website and Member Portal are also valuable resources for members. In person, on the website or over the phone, the EBF provides you with a direct line of communication."

# TOP 5 MOST COMMONLY ASKED QUESTIONS FROM OUR MEMBERS:

- **01.** How do I find a participating CSEA Employee Benefit Fund dental provider? To search our Dental and Vision Participating Providers, click the "Provider Search" button on the home page of our website **www.cseaebf.com**. From there you can search by dentist, dental specialty, dental office name, zip code, city, or state.
- **02.** How much will the EBF pay for my upcoming dental appointment to get a crown? Your dental office needs to submit a predetermination to know what will be covered. Most dental offices have a dental claim form to make the submission. If they need a copy, our Dental Claim Form can be downloaded by visiting our website **www.cseaebf.com** and clicking the "Download Forms" button from the home page. From there you can select the Dental Claim Form from the list and download it to your device.
- Time Saving Tip: If you've already visited the dentist, call them and ask them if you can email them a copy of this form. In most cases, a dental office will need to examine you or provide a consultation before they can submit an estimate.

- **03.** How do I know which dental plan I have? You can create an account in the EBF Member Portal to view your coverage and manage account information. Our member portal can be accessed by clicking the "EBF Member Portal" button from the home page of our website **www.cseaebf.com**. It is very easy and quick to set up your account in the portal.
- **04.** How can I view my past dental claims online? Once you have created an account in the EBF Member Portal and are logged in, you can view Explanation of Benefits (EOB's) online for processed claims. They will display by clicking the "Get EOB's" button. If an EOB that you are looking for is not there, please note it can take up to 2 weeks to process a claim once it has been received by the EBF.
- **05.** Where do I direct questions about an EOB for a dental claim that was paid by the EBF? Contact our Dental Department at **1-800-323-2732**, hold for further instruction and select #2 for the Dental Unit, then press #4 to speak with a dental representative. Office hours: 7:30am 5pm Monday-Friday est.

# **Retirement Tools Explained**

Planning what benefits to elect into retirement can be overwhelming. With so many options available, how do you determine what option works best for you? Visiting **www.cseaebf.com** can make it easier – you've got TOOLS!

#### Member Portal: Research How You Used Your Dental Benefits



Did you know you can view 5 years of processed dental claims in your member portal? Why is this important? When you retire, CSEA vendors will be mailing you dental and vision program offerings for purchase. Knowing how you use your dental coverage will help you in selecting the option that works best for you.

Click on the Get EOB's tab next to Account Info. Select your name and click through claims to view the amounts paid on claims. Add up all the claims to calculate how much of your annual maximum you used each year. You will want to do this for any dependents you will cover as well. Sometimes our dependents use more than we do and you want to be sure the coverage works for everyone.

Not all CSEA EBF members have access to EBF Retiree Dental and Vision programs. To access EBF retiree benefits, a fully executed Retiree MOA between the employer and the EBF must be on file for each program on the date of your retirement.

Here's where your EBF Member Portal exercise pays off. Scroll down the Retiree Benefits page to find the Retiree Dental comparisons. Select the comparison based on the name of your current dental plan. Review the differences between COBRA (continuation of your current plan after you leave employment), EBF Retiree Dental and other CSEA vendor options you will receive after you have retired. The comparisons provide the annual maximums, as well as current costs for each option.

If your annual utilization is/was greater than \$2,000 per calendar year (the maximum under the EBF Retiree Dental Plan), COBRA would be the option to elect due to the higher dental plan annual maximum. Many retirees question if they are eligible for COBRA as an option if they are retiring. You are. If the EBF administers COBRA for your employer, the EBF will automatically mail out your COBRA documents as well as any retiree options you are eligible for after your employer has submitted your benefits termination date to the EBF in writing. If your employer administers COBRA, they will notify you of your COBRA rights. For information on Retiree options before electing COBRA through your employer, contact the COBRA/Retiree Department to discuss what options you have available.

### Other Available Tools: Useful Links & Benefits Search

Scrolling to the bottom of the Retiree Benefits page provides you with additional links such as the Retiree Guide (published by CSEA Headquarters) and the EBF Retiree Newsletter Archive.

Unsure if your employer has signed the Retiree Dental and/or Vision MOAs? Click the "Benefits Search" button on the EBF home page (below the EBF Member Portal). Select the employer type (NYS or Local Government), your County, and then click the Search Button. Select the name of your employer to find your benefits as an active employee. If your employer has signed the Retiree MOAs, information is noted under Retiree Benefits. Links to your active benefits and retiree benefits are available for downloading.
